# FOR ANIMATION IN FRANCE

Film France supports foreign animation productions in France through the following free services:

Guidance about everything a foreign production needs to know about making its project in France;

Expertise on the Tax Rebate for International Productions (TRIP) and assessment of projects' eligibility;

Assistance with finding the right animation and postproduction studios in France;

Advice on production related regulations and permits, including visas. France is also home to the world's largest animation event: the Annecy Festival and the International Animation Film Market (Mifa).

# THE TRIP

# TAX REBATE FOR INTERNATIONAL PRODUCTIONS

### VALUE

The tax rebate amounts to 30% of the eligible expenditures

€30M cap per project (meaning you can spend €100M eligible expenses per project)

Eligible expenditures are taken into account at up to 80% of the total budget

No annual envelope

### **QUALIFYING PRODUCTIONS**

To qualify for the tax rebate, an animation project must:

Be a fiction project, all scripted formats are eligible

Spend a minimum of €250K on French qualifying expenditures OR 50% of its budget, whichever is the lowest

Pass a cultural test, including dramatic content

### ACCESSING FRENCH TRIP

The tax rebate is available for production services companies / animation studios that are subject to corporate income tax in France.


