# THE TRIP: TAX REBATE FOR INTERNATIONAL PRODUCTIONS

The TRIP is intended for international producers holding the IP of a project and planning to produce all or part of their project in France through a Production Services Company.

#### **VALUE**

- 30% rebate on French eligible expenditures
- Cap: €30M per project
- Can represent up to 80% of the production's total budget
- No annual funding cap

#### **OUALIFYING XR PROJECTS**

For international productions, a project must:

- Be a scripted fiction work (any format)
- Spend a minimum of €250K on French qualifying expenditures OR 50% of its budget, whichever is the lowest
- Pass a cultural test, including dramatic content

#### **ACCESSING THE TRIP**

The tax rebate is available through a production services company subject to corporate income tax in France.

#### **IMMERSIVE CREATION FUND**

The Immersive Creation Fund is open to international XR coproductions through a French co-producer. The fund can support pre-production and production.

#### **VALUE**

- Annual budget: €3.6M
- Selective grant:
- 4 commissions per year

#### **QUALIFYING COPRODUCTIONS**

For international co-productions:

- At least 30% of the total budget must be financed by the French partner
- At least 50% of the French share must be spent in France
- IP rights must be shared between the co-producers.

## ACCESSING THE IMMERSIVE CREATION FUND

A French co-producer must be attached to the project. The French company must be established in France and not controlled by non-European capital.
